

VOLUNTEER RELEASE OF LIABILITY AND INDEMNITY CONTRACT

The undersigned volunteer ("Volunteer"), in consideration for permission to act as a volunteer for Milagro House, Inc. ("MH"), the sufficiency of such consideration is acknowledged, hereby acknowledges and agrees to the following:

- 1. <u>Volunteer Relationship</u>: Volunteer has expressed an interest in providing services, as needed, to MH on a volunteer basis. This Contract will apply to all MH events or activities in which Volunteer provides voluntary services. Volunteer hereby acknowledges Volunteer's desire to volunteer services to MH for charitable and/or humanitarian reasons. Volunteer understands and agrees that as a volunteer, Volunteer is not an employee, partner, agent, representative or contractor of MH under federal, state and/or local law or regulations. Volunteer also understands and agrees that because Volunteer is donating services to MH for altruistic reasons: (i) Volunteer has no expectation odf any comprensation, pay, fee, or benefits for the services; and (ii) Volunteer is not entitles to wages or employee benefits to which MH employees are entitled.
- 2. Waiver of Liability and Release: Volunteer assumes all risk of injury, including death, to Volunteer's person and property arising from the services as a MH volunteer. Volunteer further releases, discharges and holds harmless, for Volunteer and Volunteer's heirs, administrators, executors and assigns, MH, its directors, officers, employees, agents, administrators, insurers, successors and assigns, from all liability and claims of any and every kind and nature, whether arising out of negligence or otherwise, for any injuries, including death and loss of property, and including but not limited to theft, loss, negligence, invasion of privacy, fire or other acts, and Volunteer hereby waives all current and future claims, whether or not known and whether or not foreseeable, against such aprties arising from any loss, damage or injury, including death, to Volunteer's person and property arising from the services as a MH volunteer.
- 3. <u>Indemnification:</u> Volunteer agrees to indemnify, hold harmless and defend, to the fullest extent permitted by law, MH, its directors, officers, employees, agents, administrators, insurers, successors and assigns from and against any and all demands, claims, liabilities, suits, causes of action, judgments, damages, losses, penalties, and/or expenses of any kind or nature whatsoever, including attorneys' fees, arising, directly or indirectly, from or resulting, directly or indirectly, from Volunteer's performance of volunteer services hereunder, however caused and regardless of any actions or omissions of MH.
